INFORMATION NOTICE ON THE PROCESSING OF PERSONAL DATA

(pursuant to Article 13 of EU Regulation 2016/679)

The Davide Astori ETS Association, as Data Controller, informs you that the personal data you provide with this application will be processed for the following purposes:

a) Management of the admission application: assessment of requirements and execution of the admission procedure as governed by the Statute. The legal basis is the performance of pre-contractual measures.

b) Management of the membership relationship: in the event of admission, for the administration of the relationship (entry in the members' register, convening of assemblies, management of membership fees, sending of institutional communications) and for compliance with legal and statutory obligations. The legal basis is the performance of the membership contract and compliance with legal obligations.

c) Compliance with legal obligations: to fulfill obligations provided by the legislation governing Third Sector Entities and by tax and civil law.

The provision of data is mandatory for the above purposes. Failure to provide such data will make it impossible to process the application for admission. Your data will be retained for the entire duration of the membership relationship and, after its termination, for a period of 10 years in order to comply with legal obligations. In the event of non-admission, the data will be deleted within 12 months of notification of rejection. The data will not be disclosed and may be communicated only to third parties for compliance with legal obligations (e.g., tax advisors, insurance companies for volunteers).

As a data subject, you have the right to request from the Data Controller access to your data, rectification, erasure, restriction of processing, as well as the right to object to processing and the right to data portability. These rights may be exercised by sending a communication to the Association's email address. You also have the right to lodge a complaint with the Supervisory Authority.
